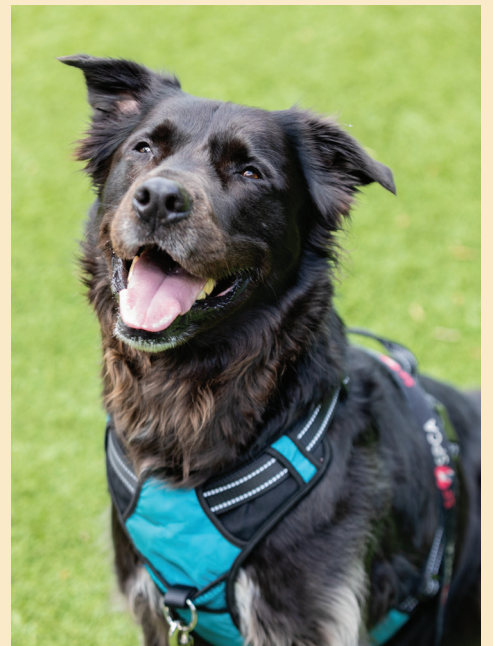

A Note From Dr. Scarlett

This past year marked another pivotal chapter in the journey toward realizing Vision 2030—a strategic plan to expand access to veterinary care, reduce shelter overcrowding, and improve the lives of 8 million animals by the end of this decade.

Across California, shelters continue to face unrelenting challenges: rising intake, a shortage of veterinary professionals, and barriers that prevent animals from receiving care. At the San Francisco SPCA, we see every challenge as a call to act strategically, compassionately, and in partnership with others who share our belief that every animal deserves a healthy, loving life.

In fiscal year 2024–25, we expanded free and subsidized veterinary services through our San Francisco Community Veterinary Clinic and Mobile Vaccine Clinics, while increasing access to spay/neuter in San Francisco and the Central Valley. Our Mission Hospital played a vital role in this system of care, providing critical treatment that kept pets healthy and with the families who love them. These efforts improve pet health in our communities while helping reduce shelter overcrowding at its source.

Our shelter and adoption programs also thrived, thanks to passionate volunteers and staff who ensured that animals received the care they needed to find homes. We continued to lead by example, not only in adoption outcomes but in advancing sheltering practices that prioritize animal well-being.

We also paved the way for animal advocacy, bringing together lawmakers and animal welfare partners to strengthen protections and remove barriers to care. By helping organize statewide events like California Adopt-a-Pet Day, we celebrated what’s possible when shelters, rescues, and communities unite for a common purpose.

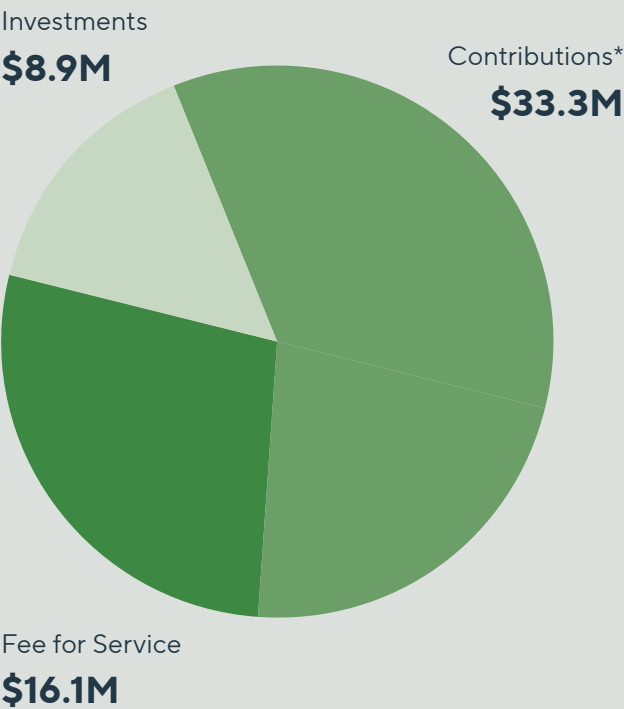


With your support, we provided more than **\$5.2M** in free and reduced-cost veterinary care to the San Francisco community.

Our work expands across California:

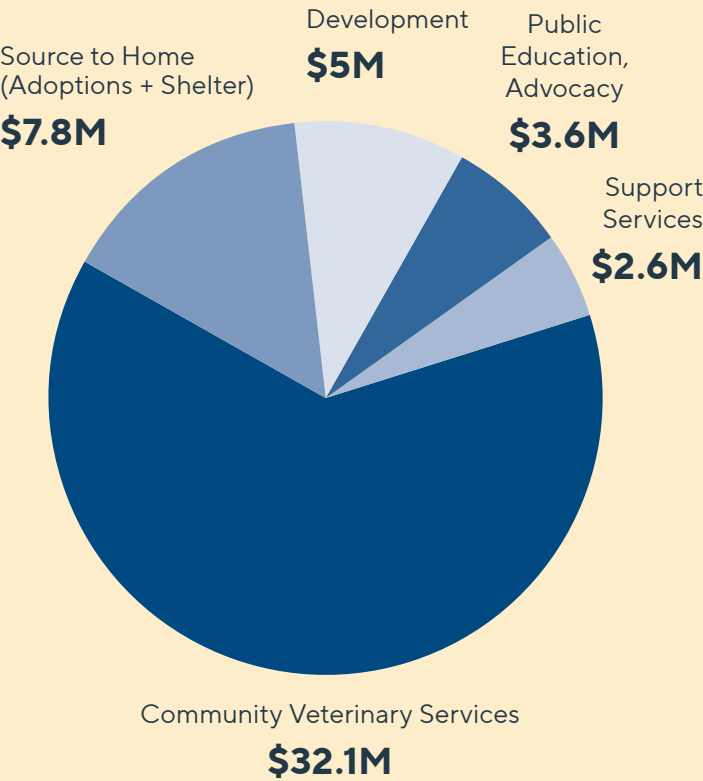
- We provided direct services for **99,017** total animals.

REVENUE \$58.4M

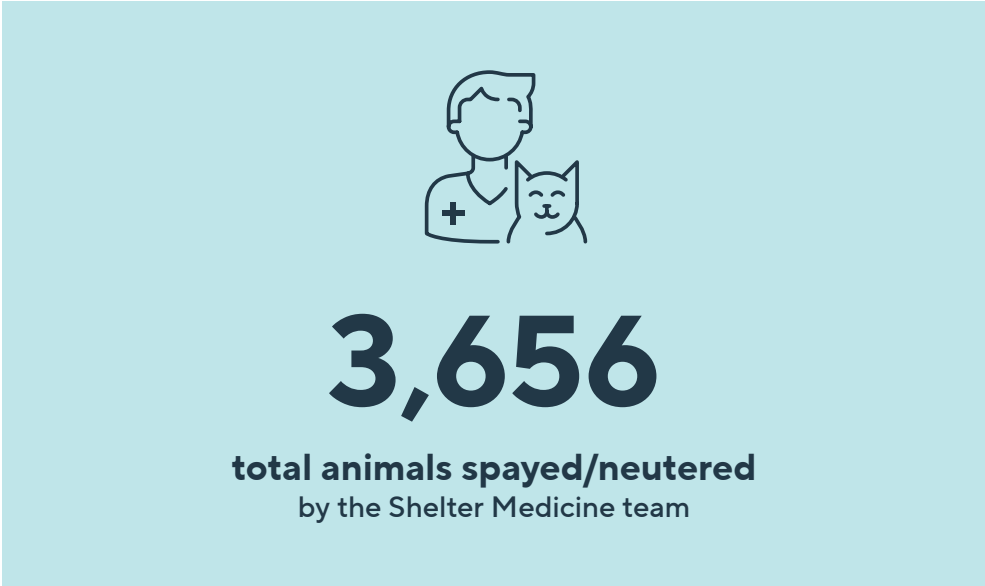

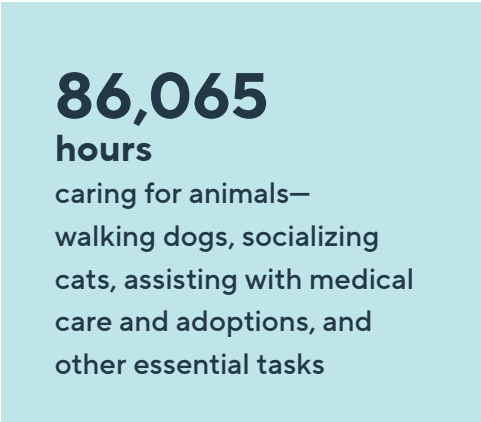

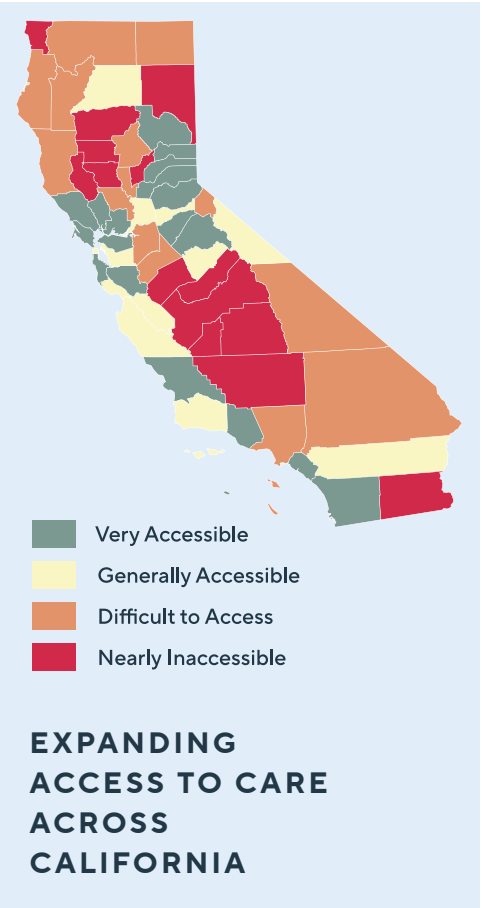
