ACCESS TO VETERINARY CARE IS EXTREMELY LIMITED IN THE CENTRAL VALLEY, SO WE HAVE DEEPEENED OUR PARTNERSHIPS IN FRESNO, KINGS, AND TULARE COUNTIES, AND THE CITY OF STOCKTON. EACH YEAR, THE SF SPCA VOLUNTEERS AND STAFF TAKE ANIMALS TO VISIT NEARLY 60,000 COMMUNITY MEMBERS IN OVER SAN FRANCISCO FACILITIES: HOSPITAL WARDS, NURSING HOMES, PSYCHIATRIC CLINICS, SENIOR CENTERS, SPECIAL SCHOOLS, HOSPICES, AND SAN FRANCISCO INTERNATIONAL AIRPORT.
